Explanatory note

The Indian Medical Device Rules 2017 mark a pivotal moment in the regulation of medical devices in India. By establishing a comprehensive regulatory framework, the MDR 2017 **As blood centres** are required to obtain licenses from CDSCO to operate legally (**in form 28C**), similarly medical device manufacturers producing blood centre equipment must secure licenses before manufacturing and their products for sale in India (**in form MD-5**). Both blood centre equipment Manufacture and the blood centres themselves fall under the licensing regime introduced by Central Drugs Standard Control Organization (CDSCO)
